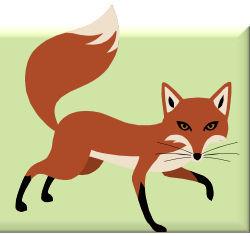

For 50 years the *Fox Point News* has been the primary method for communicating official Fox Point business and complying with state laws on certain matters. The newsletter has been the reliable go-to source for information related, although not limited, to:

Who Lives in Fox Point?

At its April meeting your board of directors took action to implement the following:

- Require all homeowners who continue to own in Fox Point but no longer live in Fox Point to promptly notify FPHA of their forwarding address, phone number, and e-mail address.
- Require all homeowners who lease or lend their property to others to promptly send the FPHA a copy of the lease or memorandum of understanding, including the occupants' names, phone numbers, and e-mail addresses, no later than the date of occupancy. The rent value may be redacted for privacy purposes.

This information will help the association to extend a proper welcome to the new residents and to make them eligible for participation in social events, competitive youth water sports, and the tennis program. It will also give them access to the pool and the lake.

Action Required

Given that this is a new requirement, we have some catching up to do. Therefore, all homeowners who do not presently reside in Fox Point or who lease or lend their properties to nonowners must make this disclosure—this month. Do it now while it's on your mind. HAPPY SPRING!!! This is the start of the season for the Common Grounds team.

Landscaping Maintenance

We have initiated a three-year agreement with Schmechtig Landscapes to handle the seasonal lawn care and planting duties for Fox Point's common grounds. They did an exceptional job last year, and I expect nothing less from them in the coming years. They manage our spring cleaning, weekly landscaping, mulching of garden beds and the playground at the pool-and-tennis-court complex, grass repair, and light trimming. I try to walk the neighborhood on a regular basis, but if you see any detail that they have missed in the weekly maintenance, please send me an e-mail and I will get them to take care of it.

Landscaping Capital Projects

That same team will be replacing any landscaping that was lost at the pool-and-tennis-court complex during last year's rebuilding of that portion of the neighborhood. They will also be completing the new landscaping design up at the Valley Road entrance gardens. They tell me that we won't see the true impact of the plantings in these two areas for at least another year or two while the new plants and flowers mature.

Fence Repair

I had been hoping that the Valley Road entrance projects were close to completion—until Mother Nature decided to knock a tree down on the wall at the southwest corner of that entrance a couple of weeks ago. We are currently getting quotes to repair the damage that was done to the southwest fence. My hope is to have the repairs and plantings done by early to mid-May, depending on the weather. This should complete the projects that were in place for that entrance, including new lights and electrical infrastructure on both the north and south sides, complete redesign of the landscaping, repair of the fences, and modifications to the water-access points on the islands at the north- and south-side entrances.

Big Old Reminder for Residents along Lake Cook Road

If you live along the fence line on Lake Cook Road, please remember to trim your trees and bushes so that they DO NOT, DO NOT, DO NOT hit the wood fence. The single largest deteriorating factor for that fence is the vegetation (trees and bushes) that hits it from within the properties along Lake Cook Road. This fence is the property of Fox Point, and as such, we all (that is, all Fox Point residents) must pay to have it replaced. Past Common-Grounds folks (including me) have tried not to be too annoying when it comes to this issue, but please keep in mind that the beautiful wood fence is celebrating its 10th birthday this year and has a replacement cost of over \$96,000. If my data is accurate, we own close to 3,500 linear feet of fence along Lake Cook Road. Thank you for your help.

Mosquitoes

We will again be having the Clark Mosquito team out each week to address the pesky little critters that hang out in the tennis-court and pool areas of Fox Point. They will come out and do their thing once a week on Thursday mornings until the season ends on or about September 1, 2016.

Trees

We also continue to fight the battle with the emerald ash borer, which has killed many trees in the local area. I have a team set up to remove six more large and very dead trees along the lot D perimeter at Meadow Way in the coming weeks. This should complete the removal of trees from the common areas of Fox Point, unless we want to go crazy and remove the remaining dead trees in lot D.

BOARD REPORT: COMMON GROUNDS (CONTINUED)

Path/Asphalt

We will be initiating crack-filling and sealing at two points in Fox Point. The first area will be the driveway at the boat docks. This area will be repaired, cracks will be filled, and the entire driveway will be seal coated. We will also be doing the same for the path that runs on the south side between Oak Ridge Circle and the Station-Lines school complex. I have been working with the school district to get the hole repaired on that path, which is on their property line on the west part of that path. They have been given the money to repair the hole, as well as the drain below that hole, sometime this summer. Once their repair work is completed, we will fill the cracks along the path and seal coat it.

I hope everyone starts to see the impact of our investments as they drive or walk through the neighborhood. I also had the landscapers plant quite a few bulbs last fall at the entrances, in front of the pool house, and at the boat docks. These bulbs are now beginning to bloom.

BOARD REPORT: LAKE

Let me start off by saying thanks to Henri Kokke, who has offered to help me monitor Lake Louise this year. We have chosen to step up our level of lake monitoring and will be taking monthly samples of water for analysis. We will also continue to monitor depth visibility and water quality with Secchi disks. This effort will continue to help us collect data for future use.

EAM has been checking our lake weekly for the past month or so. We have needed only one chemical application so far. This year we are using a new treatment called SeClear. It is an all-in-one algaecide and water-quality enhancer. This is an improvement (and is modestly more expensive) than the copper-based chemical treatments that we used in years prior. The main difference is that along with killing algae, it also binds to phosphorus and suspended solids found floating in the water. This reduces the fuel for algae growth and should incrementally improve water quality. For more info on this product, visit sepro.com.

EAM also reinstalled the bubblers in the back bay and the retention pond on the south side. These bubblers are there to promote water movement in areas where it is stagnant and inhibit thicker algal blooms. PLEASE DO NOT MOVE THESE BUBBLERS TO REDIRECT WATER FLOW. That is not their purpose, and they are not really strong enough to develop their own current.

In last month's report, I mentioned that Lake County would be coming out at the beginning of April to go over their study of Lake Louise. This 90-minute meeting (on a Friday night) was attended by a substantial majority of the Lake Committee and others. In all, we had close to 20 people listening to and asking questions of our Lake County liaison. All of the data and information provided will be posted on the Lake County website (it is a 20MB, 50+ page deck). A link to the deck will be posted when it becomes available.

Lake County's studies over the summer of 2015 confirmed that water quality is continuing to diminish. A high-level summary of the findings is as follows:

1. Lake Louise is a shallow, nutrient-rich lake with deteriorating water quality.
2. The high level of Total Suspended Solids (TSS) indicates that sediment is the primary source of low quality.
3. Nutrients released from the sediment (phosphorus) are the fuel for algal blooms. No aquatic vegetation exists to reduce these nutrients.
4. The high population of bottom-feeder fish (carp) helps to exacerbate the level of Total Suspended Solids.

BOARD REPORT: LAKE (CONTINUED)

Given this information (and reinforcement of information from previous studies), I have created several subcommittees of the Lake Committee. They are tasked with looking at different actionable areas that can improve the quality of the lake. Included is a group focused on Dredging, Vegetation Management, and Wildlife Management. Chemical management is another avenue that will be studied. I am hopeful that during the summer months we will be able to develop some multiyear plans for Lake Louise.

Finally, for those of you who own boats kept at the boat launch, please remember our “Your Boat Must Float” campaign. The Mickey family will be out there from 1:00–4:00 on May 28 and June 12 to make sure your boats are operational and not just pretty decorations. If you know that your boat is not operational or you want to dispose of it, please reach out now. We will gladly make arrangements to recycle it.

BOARD REPORT: POOL

We are looking forward to another summer enjoying our new pool! There are a few changes in store this season that we think our families and residents will appreciate.

The pool will open on **May 27**, the Friday before the Memorial Day weekend. School gets out early this year, so we thought it would be nice to be open for the first day of summer break! In addition, we have made the following changes for this season. We are testing the waters regarding different open hours to give families the opportunity to get more use out of our wonderful pool.

1. On Saturdays and Sundays the pool will open at 10:00 a.m. throughout the summer season until Labor Day.
2. Families with small children (under the age of 5) will be able to use the baby pool when swim-team practice is in session (Monday–Friday, 8:00–11:00 a.m.) Please note that only small children supervised by an adult will be allowed in the pool during this time. We will be monitoring this closely to ensure that we provide a safe environment for the children. Also, all families, including swimmers, need to vacate the pool area promptly at 11:00 a.m. to allow time for preparing the pool to open each day.
3. After swim-team season ends, the pool will be open one day a week at 11:00 a.m. for five weeks prior to the start of school. The day of the week chosen for that will be communicated in the August newsletter.

As mentioned above, we are testing some options for the pool’s open hours, and we encourage everyone to take advantage of these options. If we see high usage of the pool (one of our greatest assets!), we can revisit the subject of extended hours again next year.

We are pleased to announce that we have again selected Pool Watch to manage our pool for the next three years. See below for the management staff and lifeguards who will be taking care of our pool this summer.

The **May Grey Foxes meeting** will be held as usual on **Thursday, May 5**. However, in response to increasing frustration with our prior meeting space, we are going to meet at the **Onion Pub & Brewery**—see details below. We owe Stan Stack a big thank you for researching a number of alternatives before finally finding this restaurant, which we hope will be a better location for holding enjoyable and educational meetings.

Lunch at the **Onion Pub** will start at **noon**. However we encourage you to come around **11:45 a.m.** to perhaps enjoy a cocktail and some conversation with your neighbors. We also encourage you to invite any of your Fox Point neighbors and friends who may have an interest. And feel free to **invite your spouse or significant other**.

Our speaker will be **Rebekah Snyder, the Executive Director of the Preservation Foundation**. Her presentation—the “**State of the Preserves**”—will provide an update on the current state of, and future plans for, the Lake County Forest Preserves. Fox Pointers should have a particular interest in the clearing activity we have observed in neighboring Cuba Marsh along Ela and Cuba Roads.

The **Onion Pub & Brewery is located in Lake Barrington at 22221 North Pepper Road**—4 miles north of Highway 14.

The cost of lunch will be \$19, which includes tax and tip. We will have the following four menu items to select from:

1. **Spinach Salad:** Baby spinach tossed in balsamic vinaigrette with strawberries, toasted almonds, dried cranberries, and feta cheese.
2. **Onion Pub Burger:** 8-oz. patty served on a toasted onion bun with crispy onion strings, fresh tomato, onion, lettuce, and pickle. Add American, pepper jack, provolone, cheddar, or swiss cheese.
3. **Grilled Chicken Sandwich:** Fresh chicken breast served on a brioche bun with tomato, onion, lettuce, and pickle with your choice of preparation: grilled, blackened, BBQ, or buffalo-style.
4. **Reuben:** Thinly sliced tender corned beef, sauerkraut, swiss cheese, and thousand island dressing on marble rye.

Items 2 through 4 above will be served with your choice of french fries, sriracha chips, or honey-lime coleslaw.

As usual, we are eager to hear any suggestions for future speakers—either in terms of a specific individual or a general topic, such as finances, travel, health, and so forth—that you think might be of interest to the group. We look forward to hearing your ideas.

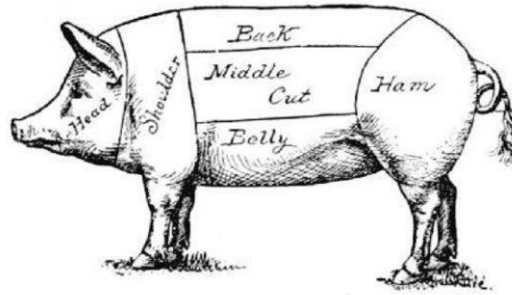

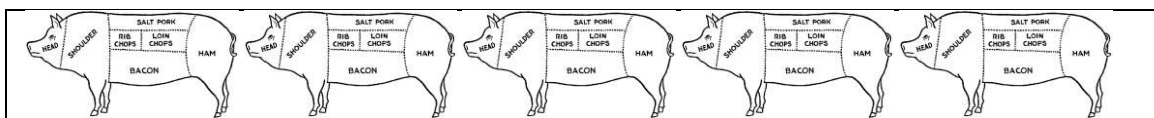

Tennis Court Regulations

The three Fox Point tennis courts are available for the exclusive use of Fox Point residents and their guests. Regulations governing the use of the courts are the responsibility of the Tennis Committee.

Court Time: Courts are available on a first-in-line basis and are limited to 1 hour of play if other players are waiting to get on the courts. Fox Point Tennis lessons and tournaments have priority for court time.

Men's Open Play: From May through September, Saturday morning is set aside for men only. Restrictions as follows: East Court, 8–9 AM; the other 2 courts, 8–10 AM.

Tennis Lessons: Programs and times will be posted in the monthly newsletters.

Attire: Players are required to wear proper tennis attire to include a shirt and tennis shoes at all times. Only nonskid tennis shoes are allowed on the courts.

The tennis courts are for **TENNIS ONLY**. Biking, rollerblading, skateboarding, hockey, dog walking, etc. are not allowed.

The rules set forth for the tennis courts may be revised at any time to accommodate suggestions from residents. The Tennis Committee is available for any rule clarification.
