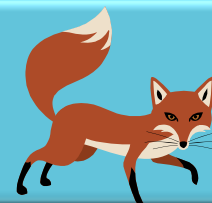

If you have a home improvement project coming up please turn in your Architecture form (on the Fox Point website, [www.foxpoint.org](http://www.foxpoint.org), under Download Forms), signed by all neighbors that are in the sight line prior to starting the project.

The process is simple! Our goal is to have all neighbors following this procedure to ensure fairness within our neighborhood.

We vote on architecture requests at our monthly Board meetings, which take place the third Monday of each month. Please submit all paperwork to me (100 Old Mill) by the Friday before the meeting so I have time to review it and connect with you regarding any questions prior to the meeting. *Please do not start a project prior to approval.*

## BOARD REPORT: SAFETY AND WELFARE

Let me just start by saying...SLOW DOWN - SOMEONE IS GOING TO GET HURT OR WORSE! I know this is directed only at a small handful of residents and most of us are conscious of our speed as we move throughout the neighborhood. However, it has been getting very bad as of late and residents are videotaping and photographing speeders to report directly to the police.

Also a friendly reminder to everyone, the pathway leading to Lines and Station is there so that Fox Point families may WALK to school without having to cut through homeowners' yards. It is not intended to be used as a drop off and pick up zone for Fox Point families or any other Lines and Station families. Increased traffic in this area creates a safety concern for those families who are on foot, as intended. In the past, several children have been nearly struck by automobiles.

While I understand that it is not always convenient to drive through the Lines or Station drop off/pick up line, we are asking that you follow the same rules as all other families. If you choose to walk to school from home, please take advantage of the pathway provided. Otherwise, please drive through your respective drop off/pick up line. Thank you for understanding, and while we believe you will comply with the rules we have set, Barrington Police Department will frequently patrol the Fox Point neighborhood before and after school as an extra precaution.

### Village of Barrington Zoning Ordinance, Chapter 4, Part IV, Section 4.13-7.B

#### *Garage sale signs shall be permitted subject to the following regulations:*

- Garage sale signs shall be permitted only in conjunction with garage sales that conform to the other applicable requirements of these (*Barrington*) Sign Regulations and other applicable provisions of the Village of Barrington Municipal Code.
- No garage sale sign may be erected without having a permit to conduct said garage sale as required by Chapter 13 of the Barrington Village Code.
- One (1) garage sale sign shall be permitted per garage sale, except that garage sales on corner lots may have two (2) signs.
- Signs may be posted only on private property or on the street right-of-way directly in front of the lot on which the garage sale is being held.
- Signs shall be posted only on the day or days of the garage sale and shall be removed by 9 PM of the last day of the sale.
- Signs shall not exceed eight (8) square feet in surface area and five (5) feet in height.

#### **Barrington Village Code – 2004**

**3-10-1: Definitions** OCCASIONAL SALES: Those sales of goods, wares and merchandise owned by the occupier of the premises or owned by a group of persons having a common sale commonly known as, among other things, a garage sale, an estate sale, a basement sale, a house sale, a yard sale and/or a rummage sale, which sale is conducted on an infrequent basis on premises zoned or used for residential purposes. Bulk sales and/or offers to sell items in bulk, the sale and/or offering for sale of multiple new or reconditioned items of the same description, the sale and/or the offering for sale of new or reconditioned merchandise brought to the premises for the purpose of sale or resale (except as above permitted by a group of persons having a common sale) and the sale and/or offering for sale of any new items are all hereby prohibited.

**3-10-2: Permit Requirements** It shall be unlawful for any person to conduct or allow the conducting of an "occasional sale", as defined herein, on premises zoned or used for residential purposes without having applied for and received from the village manager or his designate a permit to conduct such sale. Permits shall be obtained by the applicant from the village manager or his designate by appearing in person or by mail, but no permit fee shall be charged. Each permit shall be readily available on the premises covered by the permit upon request of the village manager or his designate. (1973 Code § 13-345)

**3-10-3: Days, Hours and Frequency of Sales** Occasional sales shall be permitted only on Fridays, Saturdays and Sundays for not more than three (3) consecutive days and only between nine o'clock (9:00) A.M. and sunset each day. Not more than three (3) such occasional sales shall be conducted on the same premises within any calendar year, and not more than one such sale shall be conducted on the same premises within any one thirty (30) day period. In the event of rain, an occasional sale may be held in the three (3) day period immediately following the permitted period; however, no such sale shall exceed three (3) total days. (1973 Code § 13-346)

**3-10-4: Advertising Signs** All signs giving notice of the sale shall be removed no later than nine o'clock (9:00) P.M. on the day the permit expires and shall otherwise conform to all applicable provisions of this code, including, but not limited to, the provisions of title 11, chapter 2 of this code. (1973 Code § 13-347)
