

2021 Fox Point Pool – Open Swim Policies and Procedures (Phase 4 Bridge Guidance)

I. Hours of Operation

II. Reservations

- Reservations are available for Friday-Sunday sessions
- Reservations can be made at the website: www.foxpoint.getomnify.com
- Admittance of pool attendees will be limited to Fox Point residents, employed adult nannies and guests as defined below and divided into Fee vs. No Fee categories:
 - Fees (\$5/visit):
 - Non-resident adult children of a Fox Point homeowner
 - No Fees:
 - Nannies or Live In-house guests
 - Non-resident minor children of a Fox Point homeowner
 - Non-resident minor grandchildren of a Fox Point homeowner
 - Non-resident parents and grandparents of a Fox Point homeowner
- A maximum of 150 pool slots will be available for each session
- Acceptance of the COVID-19 waiver is included in the reservation booking and at check-in and is required for access to the pool
- Pool attendees are limited to 4 reservations/week, although there are no limits for non-reserved check-ins (aka walk-ins) if space is available
- Party reservations will not be accepted at this time due to social distancing requirements

III. Check-in

- Masks are required to be worn at check-in
- Attendees are required to be checked-in to the Omnify system before entering the pool
- Pool Watch staff will verify check-in for all residents and guests
- A QR code will be posted at the check-in desk for self check-in to speed the process
- Walk-ins will be accommodated if unreserved slots are available
- In the event the pool is closed due to weather or maintenance, uncanceled reservations will not be recorded
- Reservations will be held for 15 minutes after which time may be forfeited to allow for the individuals on a waiting list and walk-ins
- Reservations not canceled before the session start time (aka No-Shows) will trigger warning messages and if persist can result in temporary removal of reservation booking.

IV. Supervision of Children

- Children under 8 years of age must be accompanied at all times by a responsible person, 14 years or older

- Children 8 to 13 must be accompanied by a responsible person, 14 years or older, until they pass the swimming test
- Swimming tests can be performed during any pool session by the Pool Watch lifeguarding staff and completion requires a Child Authorization and Emergency Form ([link here](#))

V. Pool Use and Safety

- Fully vaccinated individuals are not required to wear face coverings, but may choose to do so based on their preference. By entering the Fox Point pool facility without a face covering, you are truthfully verifying that you have been fully vaccinated
- Any individual who is not fully vaccinated and who is over the age of 2 and able to medically tolerate a face covering shall be required to wear a mask or cloth face covering, when entering and exiting the pool house and when social distancing is not possible
- All attendees are expected to practice 6 feet social distancing
- Chairs and tables are not to be moved as they are positioned to comply with social distancing guidelines
- 2 lap lanes will be reserved for lap swim at all times
- The diving well will be open
- The wading pool will be open
- Showers and bathrooms will be open
- Food and beverages are permitted

- I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
